The MidAtlantic Pastel Society (MAPS) is sponsoring an exhibit in the Cedarfield Gallery at the Cedarfield Retirement Community, 2300 Cedarfield Parkway, Richmond, VA 23233 from May 1 through Aug. 31, 2024. This exhibit has no registration fee and is an especially good opportunity to exhibit for those new to showing their paintings. Sales will be handled directly between the artist and the resident or visitor, so there is no commission on sales to be paid to Cedarfield. Make sure your label includes your phone number. (Cedarfield reported 7 sales from a recent exhibit.) If a painting sells or you are unable to leave a painting for the duration of the exhibit, you may substitute it. Drop-off and pick-up will be at the Cedarfield Main Building. Please give the guard at the front gate your name and let them know you are delivering/picking up paintings. Drive down Cedarfield Parkway to the main entrance area. Park in front of the main building with large columns or pull under the covered area to the side. Once inside the lobby, check in with the concierge, then proceed up the stairs on the right one level or take the elevator to the left (select 4<sup>th</sup> floor) to reach the gallery.

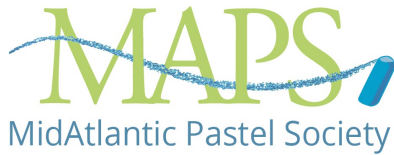
**Registration** – Capacity for this exhibit is 35 paintings. Members may register up to 2 paintings. To register for this exhibit, [click here](#). There is no registration fee for this exhibit. A paid MAPS membership for the 2023-2024 fiscal year is required to register, and payment of dues for the 2024-2025 fiscal year will also be required no later than June 1, 2024, to participate in this exhibit (MAPS fiscal year is June 1 through May 31 each year).

**Requirements:** Exhibitors must adhere to requirements for exhibiting with MAPS found in [MAPS Standing Rules Addendum – Exhibit Rules](#) which is in the Members Only Section on the MAPS website. Please review them carefully.

You may use your own labels or the labels that are included on the last page of this prospectus on the back of your painting. You will also need to fill out a MAPS Wall Card (available at drop-off if you don't have any) to display with your painting.

**Publicity** – Because Cedarfield is a private community, this exhibit will be open only to its residents and their guests. Therefore, MAPS will not publicize the exhibit on our social media pages at Cedarfield's request, but Cedarfield will publicize this exhibit internally in their monthly newsletter.
