The MidAtlantic Pastel Society (MAPS) is sponsoring our Spring 2023 exhibit, “Serenity and Meditative Works,” at Glenmore Yoga & Wellness Center, Gleneagles Shopping Center, 10442 Ridgefield Parkway, Richmond, VA 23233 from March 8 through May 10, 2023.

Venue – Glenmore Yoga & Wellness Center, dedicated to hatha yoga, assists individuals in improving their health and quality of life through integration of body, mind, and breath. MAPS members are invited to display works expressing the theme of this exhibit, “Serenity and Meditative Works.”

Registration – Members may submit up to two (2) paintings. To register for this exhibit, [click here](#). There is no registration fee for this exhibit. Registration begins November 16, 2022, and will end February 29, 2023, unless gallery capacity of 35 paintings is reached sooner. A paid MAPS membership for the 2022-2023 fiscal year is required for entry.

Publicity - Artists may submit photos of paintings for possible use in publicity materials no later than February 15, 2023. Image photos must be 1000 pixels on the longest size and 300 dpi resolution, taken before the painting is framed and under glass (see the Exhibit section of MAPS website for sizing tips). Image file names must be in the format ArtistName_Title_Size_Price.jpg. and emailed to Patti Jeffries at patti.jeffries@gmail.com. Glenmore Yoga will publicize the exhibit through its standard media sources and MAPS will publicize the exhibit through its website and social media pages (Facebook, Instagram). Artists are also encouraged to provide information about the exhibit to their patrons, family, and friends.

Theme, sales, limits on subject matter – All works must express calm, peaceful, serene themes to be accepted into this exhibit. Glenmore Yoga will handle all sales, charging 30% commission. At least 75% of the paintings must be for sale. Small to mid-sized paintings (ex. 8”x10” to 16”x20”) work best in Glenmore’s gallery space, although they are willing to hang one larger painting in their lobby.

Requirements: All work must be at least 80% soft pastel and must be original (i.e., may not be work copied from another artist’s painting, from published photographs or other copyrighted material). The back of the painting must contain artist’s name, title of painting, size, and price. You may use your own labels, or the label that is included on the last page of this prospectus. The label can be stapled over the wire or taped to the painting’s back. Refer to MAPS Standing Rules Addendum – Exhibit Rules for a complete list of all requirements for exhibiting with MAPS
