The MidAtlantic Pastel Society (MAPS) is sponsoring our 5<sup>th</sup> Annual All Members Judged Exhibit. This exhibit will be judged by Jeri Greenberg and will be an all virtual exhibit hosted on the MAPS website. Cash prizes will be awarded as follows: 1<sup>st</sup> Place - \$250, 2<sup>nd</sup> Place - \$150, 3<sup>rd</sup> Place - \$75. Judging will occur during October with awards being announced around mid-October. Award winners will be notified by email and this information will also be posted on the MAPS website with the virtual exhibit.

**About our judge:** Prior to becoming a full-time painter and teacher, Jeri Greenberg was a fashion illustrator and sportswear designer as well as working in advertising. Jeri teaches weekly classes at the Cameron Art Museum in Wilmington NC, and does demos and workshops around the country, as well as jurying pastel exhibits. She is represented by Water + Color Gallery, Art in Bloom Gallery and is a featured artist at Protocol in Wilmington, NC.

**TO REGISTER:** To register for the exhibit, [click here](#). Each artist is allowed to enter one painting, and the entry fee is \$25. You must be a paid MAPS member for the 2021-2022 MAPS year in order to exhibit.\* You may pay your entry fee either by check made payable to MidAtlantic Pastel Society and mailed to Carol Cullinan, 3202 Klaus Ct, Glen Allen VA 23060 or you may use Zelle to pay your entry fee. Information about using Zelle is on the MAPS website in the members only section under membership. To find MAPS on your bank's Zelle page, enter the MAPS email address, [midatlanticpastelsociety@gmail.com](mailto:midatlanticpastelsociety@gmail.com), when asked for the recipient. Please also put "for virtual exhibit" in the memo section of your Zelle payment. Registration will close on September 15, 2021.

All work must be primarily soft/dry/hard pastels and must be original (i.e. may not be work copied from other artist's paintings, from published photographs or other copyrighted material). There is no specific theme; paint your favorite subject – landscape, still life, portrait, etc.

A photo of each entered painting must be provided to Carol Cullinan at [chcullinan@gmail.com](mailto:chcullinan@gmail.com) no later than September 15, 2021 in order to be included in this exhibit. Photos must be taken of the unframed painting, not under glass, cropped to show the painting only, and saved in high quality (300 dpi) at 1920 pixels on the longest side. File naming convention for each submitted painting is Artist Name\_Title\_Dimensions (height x width)\_Unframed Price\_Framed Price. It isn't necessary to provide both prices, but you will need to specify for each price whether it is the unframed or the framed price. The price may also be NFS. If you need assistance/instructions on how to prepare your file, please contact Carol at [chcullinan@gmail.com](mailto:chcullinan@gmail.com) or on her cell at (804) 240-2061. While Carol will assist, we reserve the right to reject an entry when the image is not of acceptable quality.

MAPS will publicize the exhibit on our website and our Facebook page, and artists are encouraged to provide links to the exhibit to their own contacts. All sales will be handled between the purchaser and the artist directly. The virtual exhibit will have a form that may be used by potential purchasers to request contact information for the artist whose painting they wish to purchase. Contact information for each artist will not be provided unless requested to support a purchase.
